Rules and regulations

§1

These Regulations define the rules applicable to the Departure of the Students' Union of the University of Warsaw "Campus Summer UW 2022", hereinafter referred to as the Field Trip and/or Event, as well as the consequences resulting from failure to comply with these obligations.

§2

The Event takes place at the "Resort Niegocin" (ul. Niegocińska 7, 11-500 Wilkasy, district Giżycki, Warmińsko-Mazurskie voivodship), hereinafter referred to as the Resort or Center, from September 23 to September 28, 2022.

§3

1. Campus Letni UW 2022 is organized by the Board of the Students' Union of the University of Warsaw and the Foundation "Universitatis Varsoviensis" for the Development of Social Competences. During the field trip, the Organizer is represented by the field trip staff, which consists of the President and Members of the UW Students' Union.
2. During the entirety of the event the organizer will be represented by the Cadre which consists of the President of the Students' Union of the University of Warsaw and persons selected by him and who are mentioned in sec. 3.
3. Members of the Cadre will be appointed by the President of the Students' Union of the University of Warsaw's ordinance.
4. President of the Students' Union of the University of Warsaw shall be the cadre's supervisor, and in case of his absence, a person he selects to substitute him.
5. Any matters requiring the Organizer's intervention should be immediately reported to the cadre

§4

1. The Participant of the field trip is a person who has signed up for it via the application form on the website, at the address provided by the Organizer, had successfully passed the verification process by the field trip staff, had paid the fee and received an e-mail message confirming receipt of the payment by the Organizer along with the ticket admission to the event.
2. The participants in Campus 2022 can be the following:
 - 1) University of Warsaw students
 - 2) Persons who were accepted to attend University of Warsaw in 2022 and who are of age of majority and take full responsibility for their actions
 - 3) Guests invited by the organizer
3. The organizer reserves the right to refuse to register a participant without providing an explanation. Any payment is returned to the payer's account.
4. In special circumstances, the organizer may allow the participation in the event to persons who are not students at the University of Warsaw
5. The fee referred to in §4 sec. 1 is PLN 650 for the first 50 registered persons who signed up through the application form mentioned in the sec. 1, and 750 PLN for the remaining persons. The first 50 shall be determined by the date and time of the receiving of the application by the organizer.
6. The organizer predicts the participation number at 400 people. The organizer reserves the right to change the number of spots available, introduce additional conditions for accepting the participant's application, and refuse to participate in the Camp to some people without giving a reason.
7. The Participant, by submitting the completed application form for the Campus 2022, at the same time confirms that they have read these Regulations and accept its provisions.
8. The facility mentioned in §2 possesses accommodations of varying standard, therefore differences in the standard of accommodation between participants can occur. Participant declares that they have familiarized themselves with accommodation standards of the resort in which Campus 2022 will take place, and fully accepts them

§5

1. The Organizer provides Participants with:
 - 1) accommodation and food;
 - 2) training sessions, meeting and integration events in accordance with the program with reservation to §28 sec.1
 - 3) transport from the assembly point to the place of accommodation and back at predetermined times and places;
 - 4) accident insurance.
 - 5) climate tax
2. Failure to appear at the appointed time at the assembly point referred to in §5 sec. 1 point 3) equals to resignation from the Event and does not entitle to a refund of the costs of the event fees incurred by the Participant.
3. Participants can reach the resort using their own means, but only after receiving a permission from the organizer
4. The organizer will charge each participant with a deposit in the amount of 100 PLN during participant registration.
5. The deposit will be available for pickup 30 after the event's end at the latest, with the exception of situations mentioned in sec. 6
6. Deposit refund can be negatively affected by damages done to the room or any other of the Resort facilities and during transport. Expulsion from the Campus 2022 as outlined in §16 is equivalent to forfeiture of the aforementioned deposit. The organizer shall also outline a list of compulsory activities for the participants during which attendance shall be checked. First absence during a compulsory activity will equal to the forfeiture of the 50% of the deposit amount, and second absence will result in a 100% forfeiture of the amount of the deposit.
7. Charge for damaged or lost keys that will be issued on the day of the arrival is equal to 60 PLN and cannot be charged to the aforementioned deposit.

§6

During transport mentioned in §5 sec.1 pt.3 participants are obliged to follow the directions of the cadre and drivers.

§7

1. Participants accommodated in a specific room are required to leave the room intact on the last day of the Event.
2. Participants who notice any damage to their rooms while checking in, are obliged to immediately report it to the staff, so as not to be held responsible for causing it.

§8

1. By accepting these Regulations the participant declares that their health condition allows them to take part in the Event, and in case of special conditions the Organizer has been informed before the departure about them in the sign up form.
2. Hiding information about the health condition and medications taken is forbidden and may result in the expulsion of the Participant from the Event without the right to reimbursement.
3. It is forbidden to share medications prescribed to a given Participant with other Participants of the Event and may result in the expulsion of the Participant without the right to reimbursement.
4. The organizer does not provide the Participants of the Event with medications.
5. The participant is obliged to immediately inform the Event Staff if theirs or other participants' health condition has deteriorated.

§9

1. In case of a state of an epidemiological emergency, state of epidemic or state of emergency, the organizer can add additional requirements with regards to the event in accordance with the law and guidance from the Chief Sanitary Inspectorate of Poland.
2. All participants are obliged to follow the rules outlined in sec.

§10

1. Participant is obliged to wear their identification tag provided by the organizer during the entire lenght of Campus 2022

2. Participant may not leave the area of the resort without the express permission of the organizer. Staying outside the area of the resort between 22:00 and 6:00 is prohibited.
3. The Participant is obliged to comply with the law in force in the Republic of Poland, the Regulations of the Resort, the provisions of these Regulations and follow the instructions of the members of the cadre.
4. In case of a gross violation of the law or these Regulations by a participant, the Organizer may notify the law enforcement or request the university authorities to initiate disciplinary proceedings.

§11

The Participant is obliged to respect other Participants, members of the Event Staff, staff of the resort and Guests invited by the Organizer.

§12

1. It is forbidden to consume alcohol on the premises of Resort, with exception of places that have been specially designated. In certain circumstances the supervisor of the cadre may enforce temporary or complete prohibition on the consumption of alcoholic beverages applicable to all the participants. Failure to comply may result in the expulsion from the Campus 2022.
2. It is forbidden to smoke all tobacco products in the rooms and the Resort's buildings, with exception of places that have been specially designated.
3. In the case of a gross violation of these rules the participant will comply with the order from the cadre supervisor to undergo testing for alcohol and drugs in breath, blood and other bodily fluids. Refusal to undergo the testing procedure will result in unequivocal expulsion from Campus 2022 without the right to the deposit reimbursement.

§13

It is forbidden to possess or to use any stimulants forbidden by the law of the Republic of Poland, and other psychoactive substances that have similar effects.

§14

It is forbidden to possess and to use explosives, firearms, sharp tools or other similarly dangerous objects.

§15

Indecent behaviour deviating from the generally accepted norms of behaviour is forbidden.

§16

1. Failure to comply with obligations and prohibitions described in §6-15 will lead to the Participant being subjected to the following disciplinary measures, which are, depending on the case:
 - 1) rebuke,
 - 2) informing the Head of the Educational Unit, at which the Participant studies, about the breach of the Regulations,
 - 3) loss of deposit
 - 4) Expulsion from Campus 2022
2. The Cadre Supervisor shall be responsible for implementing the disciplinary measures as well as deciding which disciplinary measure shall be applied
3. The Cadre Supervisor shall retain the right to apply the most severe disciplinary measure without applying prior measures.
4. The Cadre Supervisor may apply few or all of disciplinary measures listed in §16 pt. 1 at once. In case of the expulsion the participant forfeits the right to any reimbursement for any unused portion of the stay.

§17

In case of expulsion of the Participant from the Event, the Organizer will not refund the Participant the funds resulting from the non-use of the service provided for during the Event.

§18

1. Participants bear full responsibility (financial and legal) for damage to property and third parties caused by them during the Event.
2. If it is impossible to establish the identity of persons responsible for damages caused in their rooms during an Event, the persons registered in the given room shall bear joint financial liability.

3. If it is impossible to establish the identity of people responsible for the damages caused to other parts of the Resort during the Campus 2022, all participants shall be jointly liable.
4. If it is impossible to establish the identity of people responsible for the damages caused to transportation, all participants from that particular vehicle shall be jointly liable.
5. In the event of damage of significant value, participants will be obliged to pay the amount determined by the Resort/Transport company together with the Cadre, corresponding to the value of the damage caused.
6. Payment for damages referred to in §18 sec. 1-5, must be paid no later than the last day of the Campus 2022 or other date agreed upon with the Organizer.

§19

1. Staying on the premises on which the Event shall take place of persons who are not Participants is prohibited without the prior consent of the Organizer.
2. Participants admitting outside visitors aforementioned in sec. 1, without the prior consent and knowledge of the Organizer, will be immediately punished with the expulsion from the Event without the possibility to seek compensation for the fees paid.
3. In case of participants being found hosting 3rd parties or outsiders on the Event premises they shall be charged with a fee of 250zł/day, counting from the start of the Event.
4. Fees mentioned in §19 sec. 3 must be paid immediately.

§20

1. The Organiser does not take responsibility for the participant's actions towards the 3rd party persons
2. The Organiser shall not have custody over the Participants and their property during the Event and therefore the Organiser does not take responsibility for participant's property left in any facility during the course of the Event

§21

In case of the participant no show for reasons beyond the Organiser's control or departing from the group during the Event, the Organiser shall not be obliged to provide the Participant with the means and transportation to rejoin the group

§22

Expulsion from the Campus 2022 will result in the participant being obliged to leave the premises of the Resort. In those situation the organizer shall not provide return transportation to the expelled participant.

§23

The Organiser does not take responsibility for changes in programme due to action of higher power or unforeseen chance occurrences.

§24

1. In case of resignation from the Event, the Participant should notify the Organizer in written form, sending an email to campusletniUW2022@samorzad.uw.edu.pl.
2. The Participant who notifies about resignation from the Campus 2022, by August 8, 2022 will be entitled to a full refund.
3. Participant who notifies about resignation between 9-23 of August 2022 will be entitled to a maximum 50% refund.
4. Resignation after 23 of August 2022 or during the Campus 2022 shall not entitle to a refund.

§25

1. By accepting these Regulations, the Participant of the Event agrees to the processing of his personal data in the process of implementation and organization of the Event- in accordance with Regulation (EU) 2016/679 of the European Parliament and Council of 27 of April 2016 on the protection of individuals with regard to processing personal data and on the free movement of such data, and repealing Directive 95/46 / EC (General Data Protection Regulation).
2. In order to provide necessary organization and security, the organizer obliges all participants to provide with the following personal details: name and surname, birthdate, picture of likeness, student number (if available), address of residence, phone number, email address and phone number to a contact person.

3. Participant's personal information shall not undergo automatic processing or profiling.
4. Participant has the right to access their personal information, correcting them as well as revoking the right to process at any time. Personal information of the participant will be stored by the Organizer for a period no longer than 5 years.

§26

The Participant of the Event agrees to receive messages regarding the organization of subsequent events organized by the Event Organizer in the form of electronic mail (e-mail) in accordance with the Act of 18 July 2002 on the provision of electronic services (Journal of Laws of 2002, No. .., No. 144, item 1204; consolidated text, Journal of Laws of 2017, item 1219).

§27

1. The organizer reserves the right to amend the Regulations and the program.
2. In case of the change in the date of the Campus 2022, there is no right to reimbursement
3. In case of the cancellation of Campus 2022 due to the higher power and unforeseen circumstances beyond control of the organizer, participant may be eligible for a partial refund of the costs incurred. In such case the organizer shall attempt to provide with a full refund
4. Organizer is obliged to inform the participants of any potential date changes or cancellation without undue delay. Information will be sent to the email address provided.

§28

1. Organizer shall retain the right to change these regulations and the programme
2. Organizer is obliged to inform participants of any changes without delay

§29

1. Regulations mentioned in §6-9 and §11-15 are applicable to members of the cadre as defined in §3 sec. 3
2. Member of the cadre is obliged to follow laws of the Republic of Poland, regulations of the resort and following the directions of the cadre supervisor or person designated and the project coordinator

3. Shall the member of the cadre be found in violation of aforementioned regulations in sec. 1 and sec. 2 the supervisor of the cadre may take a disciplinary action mentioned in §16 sec.1 in accordance with the rules set in §16 sec.2-4
4. Members of the cadre are obliged to fill in their application form for the members of the cadre as defined by the cadre supervisor

§30

In certain circumstances the supervisor of the cadre may elect not to apply these regulations to certain events or persons

§31

Application of these rules shall be governed by the Cadre, using simple majority voting in presence of the President of the Students' Union of the University of Warsaw in the presence of at least ¼ of the Cadre.
